Direct Energy

KCA increased energy charges to invoice were not a sudden spike. It was just a general overall increase which all customers experienced due to the unusually long cold winter season and price of gas increase in general.

Clarification was offered by Jessica regarding the NEST device, The Nest Learning Thermostat is a smart thermostat; it is an electronic, programmable, and self-learning (i.e. senses motion) Wi-Fi-enabled thermostat that optimizes heating and cooling of homes and businesses to conserve energy.

The device is based on a machine learning algorithm: for the first weeks users have to regulate the thermostat in order to provide the reference data set. The thermostat can then learn people's schedule, at which temperature they are used to and when. Using built-in sensors and phones' locations, it can shift into energy saving mode when it realizes nobody is at home.

Tina, will donate her device to KCA, which will be installed in the lower hall, office and preschool to optimize heating.

Another device may be purchased for the upper hall.

Action Item: Alberta grant rebate for NEST may be available, Cris will enquiry.

Hall Rental Rates

Long Term rental rates that Cris had shown on the proposed schedule presented at the meeting of March 28, 2019 needed clarification. The Long Term rentals proposal was not approved. Upon follow-up with the Office Manager - wording should have read \$70 flat rate for week day evenings instead of \$70 per hr.

An email was sent out April 11, 2019 at 8:34 pm to vote on the clarification of information regarding the \$70 flat rate.

MOTION: I Christine Dombroski make a motion to that the board approve the rates as presented for Long-Term Facility Agreement rates effective April 1, 2019 as well as any existing Long Term Facility Agreement Renters to who rent for year 2019-2020 will be offered a one year loyalty rate at the existing rate. Second Darren. Quorum was reached. Accepted.

Casino Update

Kathy communicated that she submitted a request to Cowboy Casino that KCA would participate in a casino in the first quarter for 2020 which will be 18 months since our last casino.

Hall Cleaners Standard Cleaning Schedule

Cris met with Jen and Glenda regarding the “Standard Cleaning Schedule”; they are both on board with the standard hours established for cleaning the hall.

Hall Cleaners Summer Rate

Jen will not work the summer months of July and August – because there is not enough hours to keep both cleaners busy.

In order not to lose Glenda as the hall cleaner, the board decides each year how much flat rate to pay the hall cleaner plus some hourly days for bookings. The rental for July/August are usually minimal.

Motion: I, Jessica make a motion that KCA pay Glenda a flat rate of \$1000.00 and if hours exceed \$1000 flat rate than any additional hours would be paid at \$25/hr. for months July and August. Second: Shelly. All in Favour.

Broxburn Vegetables

KCA was approached by “Broxburn Vegetables” who is an Alberta producer that grows fruits and vegetables. They want to park a truck to sell the vegetables at the hall lot.

The Office Manager agreed for a 2 weeks beginning April 9, 2019 the truck will come on Tuesdays. The Office Manager had not had a confirmed date for the start of the vegetable truck.

Action Item: Does the truck require a permit to park and sell vegetables on location? An email was sent to Jenna for clarification.

CKE Meeting

Cris received an email date March 31, 2019 from Dawn who wrote “The board is feeling very overwhelmed by the amount of work going into the hall build at this point so they have opted not do anything for neighbours day.”

Donna, was notified of CKE decision.

KCA Hall Side Entrance

KCA will look into enclosing the stairway to prevent people from loitering and junk in the stairwell.

Other concerns were discussed, that near the recreation skating rink under the bushes and trees that needles were found as well as someone may have been sleeping/camping under the trees. Several board members will call 311 requesting the city to trim up the trees and brush to discourage folks from loitering.

Councillor’s Report

Our next Ward 11 Town Hall is May 23, at 7 pm at the Meadowlark Park Community Association. There will be a presidents meetings at 6:00 pm before.

We'd like to remind you about the Ward Community Event Fund that we have available. Each Ward gets a \$10,000 pool to give for community events. Councillor Farkas sets aside \$500 for each Ward until June each year. After June, communities can apply for more than this if they have a larger event they're looking to do.

Kingsland had applied for grant.

LOC2019-0034 - 837 67 AV SW -R-C2 to R-CG for duplex basement suite. **KCA neutral. Rezone supported by KCA plan.**

LOC2018-0158 - MACLEOD TR SW and GLENMORE TR SW Jack Carter **corner parcels for high-rise and mid-rise developments. Approved Apr 8. More information will be provided at the DP stage.**

LOC2019-0043 - 7103 7 ST SW – R-C1 to M-CG - **Fourplex. KCA opposes due to precedence for several south parcels and expected relaxations given small parcel size. KCA may support infills or townhomes if a contextually sensitive application is resubmitted. Some residents have commented.**

LOC2019-0046 - 7204 5 ST SW R-C1 to R-CG **Townhomes. KCA opposes due to broad precedent for east parcels on 5 Street between 69 AV and 75 AV. Resident comments to KCA are important. Open House may be in June. Rezone not supported by KCA plan.**

KCA received the first installment payment from CCG grant of \$23,625.00 on cheque # 3939874 dated April 16, 2019.
