Costco Extended Warranty for Fridge

Action Item: Cris followed up on the cost of extended warranty for Fridge Maxx Cold MXM2-48R which \$244.95. She emailed the board members to respond whether to go forward with the purchase. Quorum was received to go ahead with the purchase.

February 3, 2018 - Cris purchased from Costco - Excellence Plus+ 3 Year Appliance Warranty For Appliances over \$3000.00 - Item # 1109000 which is administrated by www.asurion.com for a total price with GST \$257.24 which processed on her credit card. Costco offered 2 years warranty and the extended is 3 years for a total of 5 years the appliance is covered until Nov 30, 2022. Cris phoned 1-888-531-8881 (Asurion) February 12, 2018 to register the fridge with Asurion.

Costco Fridge Purchase

Costco refunded KCA \$400.00 for non-delivery of the Fridge. Credit was posted to Cris's credit card February 12, 2018.

KCA hired Jay's Transportation Group Ltd.; who delivered on January 12, 2018 with a total cost of \$559.12.

Calgary Region Airshed Zone (CRAZ)

KCA received letter dated December 19, 2017 from CRAZ with a free offer for FCC to participate.

Cris responded February 4, 2018 to Tanya Carlson - Engagement Program Manager; that Kingsland would participate. CRAZ monitors air quality, educates and engages Calgary and area in learning about air quality. Further discussions with CRAZ personnel is on-going how to best handle the engagement with the KCA.

KCA was offered several options how to proceed, Cris will contact Tanya to see if they can set up a table at the Neighbours Day which will held in June to provide residents with information regarding the monitoring of air quality.

Parents' Village Calgary Play Group (APVC)

APVC signed a contract with KCA effective February 8, 2018 to meet once a week on Thursdays' from 10:00 am to 12:30 pm. They have agreed to pay \$100.00/mon to cover extra cleaning.

Cleanup Day

Ann, clean-up day coordinator communicated that KCA was not successful with original proposed dates for clean-up. KCA Clean-up day will be held September 8, 2018.

Facebook

Cris is loading events or information sessions being held at the hall to promote engagement of Kingsland residents.

President's Meeting and Town Hall

Cris attended the second President's meeting with Jeromy Farkas, February 15, 2018 which was held at Oakridge Community Hall. Approximately, 12 Presidents attended the meeting.

Main Topics Discussed:

- 1) City snow and pathway clearing - concern was voiced that the community has different pathway priority clearing then the city.

Cris brought up the crossing on 5th Street and Glenmore Trail east bound next to the high rise. The plows push the snow against the sidewalk, which blocks the crossing onto Glenmore Trail, we had to assist an individual in a

wheel chair that was stuck. It took two of us to lift and push the wheelchair through the accumulated snow. The President from the Meadowlark Community also knew about the problem at this crossing.

2) Secondary Suites a general discussion was held.

Lynda French was contacted regarding the website update. Cris will make some proposed changes and send out to the board for review before handing over to Lynda.

Kerby Centre

Cris will meet with Luanne Whitmarsh the CEO of the Kerby Centre on March 8, 2018. They are working on relocating their services and programs to the 'old Y' site at Haddon and Heritage Roads. They have been communicating with the Haysboro Community Association and would like to engage with President and the Kingsland Community as well regarding their plans.

Planning Director

Planning Committee Update: February 22, 2018.

Community Open House and Info Session – Mar 14, 2018 at Community Hall from 6 - 8 pm.

Liquor Store rejection on Elbow Dr. was appealed by applicant and hearing is delayed to April

Back lane suite rezone on Kendall Place is slated for April 16

Council hearing for Kingsmere Crescent parcel rezone from R-C2 to R-CG was held on Feb 20

Liquidation World renovation DP was approved for exterior scope. Fitness Centre for downstairs level is still under review.

69 Ave redevelopment (110 units) is still under review (council decision is expected soon)

Lloyds Roller-skating site will be occupied by Visions redevelopment is in the works.

Secondary Suites - City council bylaw public hearing decision to simplify the secondary suite process will be held in March 12, 2018. Darren stated that 72% of Kingsland residents are renters. If secondary suites become faster and easier to approve, even more renters may flood into the Kingsland Community; this is real concern for the Kingsland Community. Darren may consider submitting concerns regarding secondary suites.

Darren communicated that the eventual demolition of Kingsland Market; there will be a need for better pedestrian and accessible connection between new Trico HQ (Current Kingsland Market location) and Heritage Station. A dedicated walkway to Heritage LRT Station, proper lighting, accessibility ramps for seniors those with mobility challenges, etc.

Hall Maintenance

Ken brought concerns regarding the waste recycling bins are not utilized properly. As per household waste the right products must be put in the correct bins. The hall has three bin organic materials, recycling and garbage. He felt educating the renters may help. The Hall Manager should include orientating the renters on the disposal of waste; if they do not comply then fees should be held back. Cris will discuss with Hall Manager.

Casino - Report

Casino update - Kathy Mitchell Coordinator. The AGLC contacted Kathy as some information was outstanding in the application. She re-submitted the application.

Kathy was encouraged to send email to the Board, to call for volunteers.

Cris added this event to Facebook calling for casino volunteers are required which will held May 31 and June 1, 2018.

Social Director - Report

Jenna Findlater emailed the steps we needed to follow regarding the proposed permanent signage for the 3 playgrounds and community hall pathway. KCA would cover the cost of purchasing signs and installation. Jenna's email was forwarded to Cris.

Cash Balance Update: as of January 1, 2018 the cash balances were approximately \$1,589,000 in both TD operating and Scotiabank investment accounts. Currently, Trico Centre has sufficient funds available to complete all capital projects; both new requests and outstanding projects from prior years. Grant funding received from applications would reduce the Trico Centre direct funding amounts. Funding from additional grant sources would be pursued.

2018 Capital Budget was adopted and approved.

Shaun Kao is the acting Board Treasurer. The position is still open and they are hoping to have someone fill the position in the near future.

Resignation of Andrew Gleeson (Silverado Community). We welcomed Mike Shaw from Silverado.

Trico is celebrating 35 years. September 8 is the official 35th Anniversary Celebration.
