- b. Hall Mats
 1. In November, we talked about getting mats for the hall to protect the floor. At the time, Jen provided a number of quotes – we decided to have Jen choose the best option and then reach out to a board member for approval. As she looked into it, mats that were not a perfect fit were turning out to be much more expensive than previously thought.
 2. Jen asked KBL flooring to determine if the wear and tear in the hall was above normal. Also asked if there was any other ideas (besides mats) to add longevity to the floor.
 3. KBM suggested we purchase a few extra boxes of flooring to replace the highly used areas in the next couple years as the style will be discontinued most often yearly.
 4. KBM suggested a much bigger and heavier mat that would scrape off all the rocks and salt that Calgary brings before entering on the LPV floors. Quotes were provided on heavy duty mats.
 5. David Sanderson will look into the hall matts including some questions raised by the board:
 1. Can we get flooring replacement that is non-residential (commercial grade) that matches?
 2. How do you clean the heavy duty mats?
 3. Do the new floors have an active warrantee?
 4. Look into what the KCA used to pay for mats that are cleaned and replaced
 5. Look into heavy duty mats for the entrances (but regular duty mats for hall, etc.)
- c. National Diabetes Trust request to put a donation bin at the hall
 1. We will not move forward with this request as now is not the time while we have an un-homed population problem around the hall building.

UPDATES AND INFORMATION:

1. Business License Fee Reinstatement

In March 2021 business license fees were waived for a period of two years to alleviate stresses on businesses because of the COVID-19 pandemic. On March 17, 2023, Business License Fees are going to be reinstated. The following fees will be reinstated:

- Business license fee (new: \$172, renewal: \$131);
- Fire inspection fee (new & renewal, from \$63 - \$208);
- Planning fee (\$41); and
- Calgary Police Service (\$65)

Business license fees are used to fund business license inspectors, licensing approvals, permits and bylaw enforcement. You may renew online by logging into your account at <https://apply.calgary.ca/>, or renew in person at the Planning Services Centre, 3rd floor, Municipal Building, 800 Macleod Trail SE. 2. Decommission of Kingsland Elementary School update

Kingsland Elementary School was built in 1958 and closed its educational programming in 2007. It was used as an administrative space for 12 years and has been vacant since 2020.

The school became part of The City's facility portfolio in April 2021 and its condition was assessed for potential future use. Comprehensive investigations confirmed extensive roof damage, a deteriorating building envelope, and presence of mold. The facility is no longer safe for inhabitants and its repair is not functionally or financially feasible. As a result, in Summer 2023, the Kingsland Elementary School will be demolished, and the playgrounds removed as they were found to be near the end of their lifecycle in terms of structural stability.



3. Transit Safety Update

Wins of the Week | Highlights, Successes & Milestones

- The Community Outreach Team (COT) assisted an individual who had physically collapsed multiple times while on the transit system. COT requested EMS and the person was given a medical evaluation. The person was cleared by EMS but found to have been discharged earlier from the hospital without a residence to go to, or money to pay for prescriptions. The person was also experiencing mental health issues. COT connected the person with shelter, food, and support, as well as medical/dental health services.
- Transit peace officers attended "Coffee with a Uniform" at Banker's Hall Mall. These events help to enhance community trust and build partnerships.
- A good news story was posted in the City's [Newsroom](#) profiling one of our Transit peace officers.

Recent Initiatives

- With temperatures dipping below -19°C, the Extreme Cold Weather Strategy was activated, and Transit-provided shuttles transported people experiencing homelessness from LRT stations to shelters. A member of the Downtown Outreach Addictions Partnership (DOAP) team and a Transit peace officer were stationed on each of these buses to provide support and assistance
- Overdose responses have increased significantly in the last two weeks. The Transit Public Safety team is watching the issue closely. Calgary Police Service (CPS) is conducting several investigations into the increase, which is occurring city-wide.

Alberta sheriffs joined Calgary police officers in downtown patrols for a 3-month pilot starting Feb 27. Calgary Transit Public Safety is exploring the possibilities and options to work collaboratively with Alberta Sheriffs and Calgary Police Service with this opportunity related to transit safety.

Calgary Police Service and Calgary Transit Public Safety officers are continuing the overnight safety partnership initiative focused on reducing social disorder issues on the Transit system.

The Transit Public Safety recruitment project is in its final stages. A total of 28 Transit peace officers have been hired since the project began in September 2022 – representing a 25 percent expansion of officers. New recruits graduated in Feb and will be deployed on the system.

4. Transit Service Recovery

Calgary Transit is seeing a promising start to 2023, with better-than-expected increases in ridership. As of January, bus boardings were at close to 70% of pre-pandemic levels, and CTrain boardings were near

100% of pre-pandemic levels. In 2022, Calgary Transit predicted ridership wouldn't return to pre-pandemic levels before the end of 2023. However, January 2023 numbers suggest that full recovery is expected to take place much sooner.

Calgary Transit continues to invest in ensuring customers feel safe while riding transit. With an increase of 25% more Transit Officers since Sept 2022, Transit also continues to partner with the Calgary Police Service and City of Calgary Corporate Security to increase the number of station patrols and help identify safety issues on the system before they become significant incidents.

The 2023 RouteAhead update will be complete by Q2 and proposes a significant shift in the way transit is planned to focus on frequency. This shift, along with several important projects like Green Line, will create more predictable, reliable and frequent service, further improving service and encouraging ridership growth.

Active hiring of Transit Operators is underway to help ensure service is reliable and on-time for customers. We are currently hiring 400 bus operators and planning to recruit an additional 400 bus operators later this year.

Transit is taking opportunities to encourage off-peak ridership, like introducing free fare for youth 12 and under and a weekend group day pass. This provides incentive for more recreational travel, including to downtown as a place where people gather to celebrate and engage with arts, culture, and entertainment.

Work on the Green Line is progressing. Utility relocations and early works construction are underway, the new fleet of low-floor vehicles have been purchased and work will soon begin on design and to determine cost, risks project schedule. When complete the Green Line LRT will significantly improve Calgary Transit's ability to provide connections for Calgarians throughout the city, far beyond just commuting to and from downtown.

5. Update on Extreme Weather Response for Those Experiencing Homelessness

As predicted in las months update, we received another winter blast of cold and snow. Please take note of the following important information on programs and services in place to support Calgarians experiencing homelessness. These plans are made in collaboration with our partners at the Calgary Homeless Foundation and numerous community organizations.

- If you see someone who needs help call the DOAP Team at 403-998-7388.
- If someone is in serious distress or non-responsive, call 911.
- Calgary emergency shelters are currently operating 24/7.
- Space remains available at emergency shelters, with occupancy rates around 75%.
- The City's Animal Services Centre continues to accept pets of unhoused owners for up to 30 days. Access can be arranged through the DOAP Team or emergency shelters.

Response Activities:

- The free Calgary Transit Emergency Shelter Shuttle service was active again at end of February. The Shuttle service transports people experiencing homelessness from LRT stations to emergency shelters in the evenings. Information on the Emergency Shelter Shuttle is available at calgaryhomeless.com/ccewr/sheltershuttle/.
- Warming spaces are available at locations across the city with hours typically ranging from 7AM to 7PM depending on location. Daytime warming spaces and support list: calgaryhomeless.com/ccewr-resource-list/
- The Salvation Army Mobile Warming Station is scheduled to be at a different LRT station or community location seven days a week. Schedules: calgaryhomeless.com/ccewr/mobilewarming/.
- Wood's Homes has partnered with the Calgary Homeless Foundation to provide a warming location in Inglewood for youth 29 years old and younger, offering warm meals, laundry, shower facilities and access to winter clothing from 9AM to 7 PM every day.

6. Keeping Storm Drains Clear

Storm drains (or catch basins) are the main way stormwater gets into our stormwater management system. There are about 60,000 storm drains in Calgary which capture water off sidewalks, streets and roads. The City has an online map showing where storm drains are located.

Pooled water on your street:

If it's safe and possible to do, remove debris or snow blocking the drain. Create a channel, if need be, to help water flow. In communities built after 1990, The City installs devices in the storm drain to control how fast water flows into the system. During and after a rainfall event, these devices allow water to pool on the road (usually in a depression or low spot, called a Trap Low), until the stormwater system can accept the extra water. If the storm drain remains submerged for more than 90 minutes or you cannot safely clear ice and snow away, take a photo and submit it via the 311 App or a web request. Attaching a photo goes a long way in helping our crews respond on a priority basis. For more information and to view this map please visit calgary.ca/stormdrains.
