i. Welcomed a son earlier this week and will be taking the next 2 months off 3. Approve previous meeting minutes

- a. The minutes from November 24, 2022 will have the discussion around EDI removed and then be approved at the next board meeting
- 4. Ward 11 Update (Holly Shaw)
  - a. Report attached at end of minutes
  - b. New signal at 75<sup>th</sup> Ave and Northbound Elbow Drive. There is now an advanced green left-hand turn from northbound Elbow onto westbound 75 Ave.
    - i. Board suggests adding a sign indicating an intersection change to ensure drivers are aware of the change.
  - c. Kourtney Penner will be doing a community coffee event in Kingsland at the community hall on February 24 from 8-10 am
    - i. Board members invited to attend to chat with residents that attend. Board members will let Holly know if they are planning to attend.

- 6. Treasurer update (Jessica Pickel)
  - a. Current Account Balances
    - i. General \$91,719.25
    - ii. Casino \$3,779.52
    - iii. GIC \$89,998.73
    - b. Audit Fee Update
      - i. The cost for the 2022 Audit was \$4,800. The 2023 estimate is \$5,334 due to an increase from the FCC Auditors.
      - ii. The board suggested adjusting the audit requirement for community associations to be only every 2 years to help with the increased cost. It was also suggested that a new treasurer joining a community association would trigger an audit.
    - c. Jessica presented and worked through the Profit and Loss statement (attached) though December 2022
    - d. Jessica requested that the KCA proceed with obtaining a credit card to be used for expenses that can only be paid by credit card such as Telus and Communal
      - i. Jessica will look into if the existing debit card can be used as a credit card (debit credit) rather than getting a new card.

- 7. Lifecycle Director update (Christine Dombroski)
  - a. Report attached at end of minutes.
  - b. A new lifecycle report was completed on the hall in 2022. A draft version was submitted to the KCA and feedback was provided.
- 8. Communications / Social Media / Website update (Kaitlin Quickel)
  - a. Website has recently been updated with some new information.
  - b. Board members should reach out to Kaitlin if there is anything they want to see on the website or on social media.
  - c. We continue to see slow growth on social media numbers.
- 9. Membership Director update (Terry Casey)
  - a. Feedback was received last year on the need to update some of the membership drop routes. Terry is working on updating the routes to make sure they're up to date for this year.
  - b. Membership drive will likely be in May this year.

**MOTION:** I, Ben Ethier, make a motion that any membership purchased after May 1, 2023 will be good for the upcoming 2023/24 fiscal year (up to a 14 month membership) **Second:** Brandy MacInnis

- 10. Terry brought forward a suggestion that the KCA consider holding a Makers market.
  - a. The KCA will look into hosting in the spring where makers could purchase a table to sell their homemade items.
  - b. PBP community held something similar in fall of 2022. Might be worth reaching out to them to see how they did it. Holly will ask Kourtney about this.
- 11. Planning Committee update (Brandy MacInnis)
  - a. The LAP draft is out and available for comment. Please take a look and provide comments to Brandy.
    - i. Holly will look into and confirm the due date for submitting comments.
    - ii. Send comments to Brandy and she will consolidate comments.
  - b. Kingsland school site
    - i. Brandy and Charlotte had a meeting with Councillor Penner about the school site. Due to increased vandalism on the vacant building presenting safety and adverse impacts on the community, fencing has been installed around the perimeter. The City is working to determine next steps.
    - ii. Livewire did an article on the school site and interviewed with Charlotte for comment on the community perspective.
    - iii. Councillor Penner will also advocate for greenspace in Kingsland
  - c. Ocular clinic
    - i. Discussion with Councillor Penner also revolved around the proposed ocular clinic. Brandy outlined the community concerns around the proposed conversion. Kourtney will continue to work with the community and be active on this item.
- 12. Dog park update (Ben Ethier)
  - a. The City is planning to build steps down the hill from Macleod Trail to the dog park. While this is not yet approved, it is moving into the design stage which is exciting.
  - b. The KCA will consider doing some targeted fundraising (perhaps a dog-themed fundraiser) to put money into a beautification idea to go along with this project.
    i. Maybe connect with the local pet store to be a part of this event.
- 13. Trico update (Ben Ethier)
  - a. Community wellness centre birthday celebration is tomorrow
  - b. Ben will approach Trico Wellness to discuss a bulk donation for senior memberships for all residents with a suggestion of \$10 per housing unit.
    - i. Ben will also ask if there are any gaps in their offerings to seniors that the KCA may be able to fill
- 14. Crime prevention and safety update (Jeanine)
  - a. Crime continues to be low.
  - b. The one offender we arrested in November for daytime break and enters in your Kingsland and carrying a pistol was released in early January. He is being monitored regularly. He was arrested for breaching court conditions last weekend and released again.
- 15. Hall update (Charlotte)
  - a. Fires
    - i. Have been 6+ fires in the lower hall entrance since spring (people without homes trying to stay warm).
    - ii. It has been difficult to get assistance from the city (police, fire, bylaw) as they all direct Jen to another department.
    - iii. Perhaps Jeannine can mention to Jake that it continues to be a problem
  - b. Tables
    - i. Heavy and some are wearing out

- ii. Jen recommends selling current tables (\$25-\$50) and buying hard plastic tables that fold in half (6ft table vs current 5ft table)
- iii. Brandy recommends not purchasing the Canadian Tire ones.
- iv. The KCA does not have the money for this investment right now but will consider looking either for a grant or fundraising for such.
- c. COVID Cleaning fee
  - i. Charlotte will ask Jen if we are still charging renters for extra COVID cleaning. We will remove both the charge to renters as well as the extra cleaning request of cleaners.
- d. Jen requested a compensation review.
  - i. Ben, Charlotte, Christine, and Lars will have a meeting to review wages, comparison to other organizations, performance review, and terms of agreement (tasks, etc)
  - ii. Working group will bring recommendation to next meeting
  - iii. Make sure there are specific defined duties outlined in contract
  - iv. Request to change title on email signature to "Facility coordinator and office admin." Title change will be reviewed as part of o review wages, comparison to other organizations, performance review, and terms of agreement (tasks, etc) the review.
- 16. Succession Committee update (Kaitlin Quickel)
  - a. Discussions have taken place with Nik who joined the board tonight
  - b. Will need to meet to talk about planning committee, VP role and potentially the secretary role
  - c. Still need to designate a Casino Event Coordinator as Kathy stepped down
- 17. Social Director update (Nik Mouwen)
  - a. Will look at all events done pre-COVID (Donna's list) which Charlotte will send to Nik.
  - b. May do an updated survey of what the community wants to see and how they want to hear about it
  - c. Would like to try and ensure 2 months notice period for any decent size event
  - d. Need to ensure a multipronged approach for spreading the information to the community (to reach multiple groups)
  - e. Getting annual events sorted out will help people to try and expect things each year.
- 18. President update (Charlotte Quickel)
  - a. Clean-up day Dick is intending to organize cleanup day again this year. Brandy is willing to help if Dick needs an extra hand.
  - b. Kingsland Neighbourhood Meetings organized by Viviana to bring together various groups in Kingsland (Churches, Clare building (CUPS), St. Augustine school)
    - i. Share 'what's going on' to identify opportunities to work together and support each other
    - ii. One event coming out of this is the aboriginal event (fall) organized along with Alana Manybears of the Aboriginal Friendship Center of Calgary.
  - c. Ward 11 President's Meeting
    - i. Jan 5<sup>th</sup> had a meeting with a group of the president's from communities in ward 11. The next meeting is planned for April.
    - ii. Build relationships with other communities in the area and also with the Ward 11 councillor and staff
  - d. FCC requested board contact list (email and phone). Charlotte will share emails but not phone numbers of board members.

# 3. WARD 11 CA QUARTERLY PRESIDENT'S MEETING

Kourtney held a President's meeting on Jan 5, 2023, at the Haysboro Community Hall. It was well attended with representatives form 10 CA's in attendance. Minutes will be circulated to all CA Presidents. The next one is scheduled for Thursday April 6th. Location TBD.

# 4. 2023 PROPERTY ASSESSMENT NOTICES: CUSTOMER REVIEW PERIOD AND PAPERLESS CONTEST

The City has mailed 2023 property assessment notices and opened the Customer Review Period, which runs until March 13, 2023.

Property assessments are based on the market value of a property and is used to calculate each property owner's share of tax. 2023 property assessment values are based on a July 1, 2022 market valuation date and the property's physical condition on Dec. 31, 2022. The total value of the 2023 Assessment Roll is \$351.7 billion, an increase of 38.2 billion from last year. Overall, the typical residential property market value change was a 12 per cent increase over the previous year, while typical nonresidential market value change is 2 per cent The 2023 median single residential assessment is \$555,000, compared to \$485,000 in 2022. The 2023 median residential condominium assessment is

\$255,000 compared to \$235,000 in 2022. Most property values increased from last year due to strong sales, demand and growth in the Calgary real estate market.

The Customer Review Period is a priority for the City and the Assessment team is fully dedicated to answering questions Calgarians have about their assessment notice. The Customer Review Period is an important time for property owners to check, compare, and review their assessment for accuracy, fairness, and equity. To do so visit <u>calgary.ca/assessment</u> to access the secure online <u>Assessment</u> <u>Search</u> tool to review residential property details and property market trends report; compare property with other similar properties; sign-up for eNotice and enter the Go Paperless Contest.

From Jan 1 to Mar 31, 2023 there is a Go Paperless Contest encouraging property owners to switch from paper to electronic notices. There are 12 prizes of a \$250 Visa gift cards <u>calgary.ca/gopaperless</u>.

**Assessment Changes' Tax Implications** - This year, single residential and multi-residential property owners, are expected to have their tax share increase due, in part, to the 2023 annual assessment. This increased tax share combined with The City budgetary changes will result in an estimated increase of 5.5 per cent to the 2023 municipal property tax, based on the single median assessed home value increasing from \$485,000 in 2022 to \$555,000 in 2023.

Residential condo property owners are expected to have their tax share decrease due to the 2023 annual assessment. This decreased tax share combined with The City budgetary changes will result in an estimated increase of 0.06 per cent to the 2023 municipal property tax, based on the median assessed condo increasing from \$235,000 in 2022 to \$255,000 in 2023.

Property owners are encouraged to use the <u>Property Tax Calculator</u> to get an estimate of their 2023 property tax. It is important to note that each property's tax change will vary based on individual changes in assessment.

# <u>Property tax rates will not be finalized until after the release of the provincial budget in the spring to</u> <u>determine the provincial share of property tax and Council's approval of the property tax bylaw.</u>

#### **Other 2023 Property Assessment Roll Key Findings**

- Approximately 95 per cent of revenue neutral taxes from residential properties will stay within 10 per cent of last year's tax.
  - Single residential: Homeowners, especially those who own single residential properties, experienced the greatest increases in value, changing by 13 per cent from last year. Calgarians continue to seek suburban properties especially single residential detached and semi-detached houses.
  - Residential condominiums: Residential condominiums experienced a seven per cent increase.
     The townhouse condominium market increased by nine per cent while the apartment condominiums increased six per cent from last year.

- Multi-residential: The rental apartment market experienced a typical increase of 13 per cent.
   Leading the increases were townhouses, with high-rise and low-rise properties close behind, and finally fourplexes increasing more modestly.
- Approximately 72 per cent of non-residential properties' revenue neutral taxes will stay within 10 per cent of last year's tax.
  - Office properties: Office properties have decreased by three per cent from last year. However, the downtown office market increased by four per cent due to the strength of the A and AA class buildings, along with some compressions of vacancy and an increase of movement from lower to higher quality downtown office space. Yet, B and C class buildings continue to experience valuation pressures due to high vacancy and limited demand. Suburban office properties continue to struggle with rising vacancy leading to value reductions.
  - Industrial properties: Industrial property values have increased five per cent overall with many typically sized warehouses reflecting value increases. Large format warehouses and newer constructed warehouses reflect higher value increases as Calgary remains a major Western Canada distribution hub.
  - Retail properties: Retail properties have increased by four per cent overall, due mostly to strong sales transactions of larger format properties.

Due to processing delays at the Province of Alberta Land Titles Office, recent ownership and mailing address changes may not be reflected on the 2023 Assessment notices mailed on Jan. 4. # 5. ACADIA POOL AND FITNESS CENTRE NOW OPEN

The Acadia pool and fitness centre has officially reopened after a lengthy closure.

In 2020, The City took advantage of the extended facility closures due to Provincial public health orders by accelerating lifecycle projects at several recreation facilities, including Acadia Aquatic & Fitness Centre. While conducting the accelerated lifecycle work at the Acadia facility, it was discovered that additional work needed to be completed, requiring additional closure time. This work included repairs to the HVAC system, building envelope, roof, mechanical room, pipes and sump pump. The reopening was delayed significantly due to supply chain issues and instructor staffing shortages.

# 6. PLANNING SERVICES CENTRE RETURNS TO THE MUNICIPAL BUILDING JAN. 9

The Planning Services Centre at the Municipal Building (9800 Macleod Trail S.E.) has reopened, returning to the core to provide Calgarians with trade permits, business licenses, development and building applications, issuance of personal service licence cards, document checks, onsite payments options and onsite scanning of historical records.

In August 2022, a security event triggered the sprinkler system causing water damage to multiple floors of the building resulting a temporary relocation to other City facilities.

# 7. CALGARY TRANSIT LAUNCHES FREE FARES FOR 12 AND UNDER IN 2023

As of Jan. 1, children aged 12 and under will not require a fare to ride city buses and CTrains.

Calgary Transit has adjusted its age definitions for youth and children for the start of 2023. Prior to this fare adjustment, passengers between the ages of six and 13 were considered youth and required a ticket. Children or their guardians are asked to inform transit operators, or transit peace officers, if they are 12 or under to take advantage of the free transportation.

Passes and fares will be required for those over 12, with youth rates continuing to be available for teens aged 13 through 17, and for adults attending high school between the ages of 18 and 21.

A single fare for youth, which will include the ages of 13 through 17 and high school students, will be \$2.45 while a monthly pass will be \$82.

# 8. CALGARY TRANSIT'S COMMUNITY OUTREACH TEAM - COMPASSIONATELY SUPPORTING VULNERABLE INDIVIDUALS ON AND AROUND OUR TRANSIT SYSTEM

In 2018, Calgary Transit piloted the Transit Community Outreach Team (COT) program. In its infancy, COT was a partnership of one Transit peace officer and one outreach worker from the Downtown Outreach Addiction Partnership (DOAP) team from ALPHA house. Its mandate was to connect Calgary's most vulnerable Transit users with services. Four years later, that lone Transit peace officer, Sergeant Kitty Aalders, leads a COT team staffed by four officers and partnered with a DOAP member.

"All the services for people experiencing homelessness or addiction are downtown, but our clients are located all over the city. Clients not located downtown often refuse to go there, so they cannot access services. We meet our clients wherever they feel most comfortable – both physically and mentally," Aalders explains.

This proactive work assists the individual in the moment and reduces the load on emergency services resources and increases public safety.

On average, each month, the COT team connects with more than 300 individuals, filling out 21 housing assessments and completing 88 agency referrals. Officers advocate for clients, help them to attend appointments and connect them with detox treatment and healthcare. The COT team works closely with Police (CPS). Often, the COT team and CPS teams deal with the same clients. These individuals may be the victims of hate crimes, a missing person who has ended up on Transit, or someone whose behavior on the Transit system is generating regular concerns raised by other riders.

# 9. NOMINATIONS OPEN FOR THE 29TH ANNUAL CALGARY AWARDS

Nominate an outstanding individual or organization who gives their time and talents to making our city incredible in areas including education, philanthropy, the arts, justice, the environment, and other domains.

The Calgary Awards began in 1994 to pay tribute to Calgarians in five categories: *Accessibility, the Environment, International Achievement, Community Achievement, and the W.O. Mitchell Book Prize.* 

Within the Community Achievement category, there are nine awards: *Grant MacEwan Lifetime* Achievement, Calgarian of the Year (previously Citizen of the Year), Arts, Community Advocate – Individual, Community Advocate – Organization, Education, Heritage, Social Impact - Business (previously Commerce), and Youth.

The Social Impact - Business award will be awarded for the first time to a for-profit business that demonstrates outstanding corporate social responsibility, with special consideration given to social innovation and/or social entrepreneurship.

## **10. ONLINE INTAKE FOR HOME-BASED CHILD CARE LICENSING NOW OPEN**

As of Jan. 1, 2023, unlicensed home-based childcare providers will require a municipal business license to operate in Calgary. The City of Calgary is implementing the new requirement to regulate private home-based childcare providers and protect the health and safety of children. Private home-based child care providers can apply for their business license online, through <u>myID</u>.

A business license will be required for any private home-based childcare provider who is not affiliated with a provincially licensed family day home agency. The license will require private home-based childcare providers:

- To be certified in first aid and CPR.
- Ensure police background checks with vulnerable sector searches are conducted for providers, employees, and all individuals 18 years and older who live in the home.

A new license for childcare providers will be \$172 plus the cost of police check(s) which are \$65 for the first adult and \$55 for each additional adult and/or employee in the home. Anyone who applies between Dec. 27, 2022, and March 16, 2023, will not have to pay fees for the business license or for the police check and vulnerable sector search.

In addition, Parents will be able to confirm if their child's day home provider is licensed through the Business Map tool, a new online registry launching in the new year. The registry will include the operator's name, the business type and the community where the day home is located. No physical addresses will be included on the registry.


