Cannabis Some key pieces of information about cannabis businesses for community associations:

- Council has approved a new definition for cannabis retailing in the Land Use Bylaw. This new use is called Cannabis Store and is like the approach used for liquor stores, with unique rules and guidelines.
- Detailed information on the regulations for land uses, permits and application requirements for Cannabis Stores and other cannabis businesses are available online at www.calgary.ca/cannabisbusiness.
- Cannabis Store uses are discretionary which
- means the applications will be managed through the development permit process, including circulation, notice posting, and opportunity appeals.
- The City will begin to accept online applications for Cannabis Stores on Tuesday, April 24 at 8:00 am MT.
- Community Associations will be circulated for comment on these applications and should expect to start seeing these applications being circulated (at the earliest) the week of May Additional Work

Administration was also asked to report back to Council on the impacts of adding setback distances for payday loans and pawn shops to cannabis stores in the land use bylaw. We expect to report back to Council with this information in June, which could mean that additional setback rules could be added depending on Council's decision at that time.

We talked about Councillor Farkas' work on the Community Representation Task Force. Some of you were concerned about insufficient time to complete their survey, so we are happy to share that **the deadline will be extended to Midnight, on Sunday April 29**th. There was also an interest in having more information on City of Calgary consultation sessions, an attachment was provided which outlines scheduled and tentative consultation sessions planned throughout the city.

There was some confusion about the SWBRT construction on 14th street relating to speed restrictions. We are in close contact with the SWBRT team and our office is working to make construction go as smoothly as possible. If you see anything yourselves, or hear about any issues from community members, please contact our office and we will do our best to get it sorted out.

I have been asked to share a tool with you called Block Talk, an app that facilitates community communication by allowing people to post alerts and receive updates for their individual communities (break-ins, missing dogs, etc. It was developed by Elbow Park President, Michael Murray: https://www.blocktalk.ca/.

We also had a **request for each president to share a list of events**, so that you can all coordinate when your events will be and attend if you like. KCA list of events was emailed to Chris.

<u>Aspen Family and Community Outreach Program Information</u> KCA received an email with the following are details:

The Community Connections program with Aspen Family and Community Network Society. The Community Connections program provides outreach services to individuals in all 4 quadrants of the city. As a whole, we serve seniors, families, and individuals. Residents are paired with the Outreach Worker who serves their quadrant on a long-term basis for anywhere from 3-6 months (sometimes 1 year). Residents work with the Outreach Worker to achieve goals they have deemed important. Our services include system navigation (old-age security, Alberta Works, AISH, etc.), connection to community resources and services, advocacy, and budgeting support. Outreach Workers also support residents who are pending a disconnection of their Enmax utilities by advocating on their behalf for an extension on their disconnection notice so they may have time to secure resources for utility support. Please be advised, we do not provide financial assistance. Residents may self-refer or be referred by an agency to become a client of the program.

Permanent Signage

The board agreed not to pursue the purchase Uline Quote Message Center Sign w/posts – due to the cost factor and permits that would be required to erect.

We will continue to look for options for a permanent solution; to upgrade the message board which is located at 75 Ave and 5 Street.

Recycling Bins

The City final costs for recycling bins came in at \$375.00 per station.

After board discussion KCA decided to go with Uline to order Slim Jim Recycling bins. The board agreed to purchase 2 bins - blue (1) and green (1) ($$52.00 \times 2=104.00) and blue and green lids ($48.00 \times 2=$96.00$) for a total cost of \$200.00.

Pipeline construction to BC and fighting for Alberta's oil and gas jobs is a priority of the Alberta government.

Dear Constituents:

While in the midst of the Spring Legislative session, I am delighted to share the progress of our government provincially.

Economic growth exceeds expectations; deficit drops! While protecting public services for all Albertans.

Alberta's economy is leading the country with growth in nearly all sectors. In the third-quarter fiscal update, GDP growth is revised up to 4.5 per cent and the deficit dropped by \$1.4 billion. The lower forecast is a result of this government's continued efforts to constrain costs and improve revenue sources, such as higher non-renewable resource revenue, increased investment income and an improved balancing pool forecast.

Significant work has also been done to carefully find savings while continuing to support and protect the public services that all Albertans rely on. Whether it means negotiating practical agreements with public sector unions such as the Alberta Teacher's Association and the United Nurses of Alberta or extending the salary freeze in the public sector along with a hiring restraint across the public service. In addition, government corporate services have been consolidated and public agencies, boards and commissions have been reviewed resulting in cuts in salary and doing away with perks offered in the past. A high priority has been placed on restraining discretionary spending such as travel, all across government.

Community engagement on the South West Calgary Ring Road through several community meetings and presentations, continues and residents have provided valuable feedback. Alberta Transport together with multiple stakeholders have been able to provide ongoing information regarding plans, traffic changes and environmental considerations. Life Cycle - Report

Ken, was given approval to hire draftsperson for deck renovations which is required to be upgraded as noted in the life cycle report.

CCG grant will be applied to support ice rink renovations.

CFEP - Capital Conservation Grant application is in the works to secure funds for ice rink renovations. The grant would support 75% of the approximate total cost of \$188,000.00.

Motion: Chris Kemp-Jackson made a motion to proceed with the Capital Conservation Grant application. Donna seconded. All in favour.

Ken, had received 3 quotes he has selected Global Sports Resources as contractor for the ice rink renovations.

Motion: Darren made a motion for KCA to set aside funds of \$50,000 towards the ice rink renovations contingent that the CCG grant is secured. Seconded: Chris Kemp-Jackson. All in favour.
