Thank you to all of our Community Association (CA) executive members who attended our Presidents' Meeting on Feb. 20 at the Palliser Bayview Pumphill Community Association.

This was a very well-attended meeting with specific concerns regarding the Guidebook for Great Communities.

This Guidebook will be coming to the Planning and Urban Development (PUD) Committee on March 4 and will be before Council on April 27.

An overarching planning document, the Guidebook is in line to be Calgary's next planning document that works with new Local Area Plans (LAPs) to set the foundation for a renewed Land Use Bylaw and work to achieve the goals of the Municipal Development Plan.

Last November, Council directed the Guidebook planners to go out and test more policies. Jeromy was the only Councillor who voted against the Guidebook last fall, with concerns that the language in the Guidebook draft was too ambiguous and pushed too aggressively on density.

Highlights:

- The Guidebook is not intended to deal with zoning. It is meant to provide the foundation for LAPs.
- The Guidebook does not change the process to apply for land-use redesignation.
- The Guidebook will be applied differently in every multi-community plan.
- There are over 200 plans and policies related to development in Calgary. Many old and outdated. The City is undertaking a proactive and strategic approach to planning for growth by grouping 'like' communities together through multi-community planning, where the Guidebook would ultimately serve as policy to guide the City's 42 multi-community plans that encompass Calgary's communities.
- The next multi-community plans, which are midway through public engagement, are the Heritage and Westbrook communities.
- There are two more multi-community plans slated to proceed this fall; hinged on whether or not Council passes the Guidebook.
- The first multi-community plan, the North Hill Communities Local Growth Planning, will be brought forward at the March 4 PUD committee meeting, along with the Guidebook.

The FCC has described the Guidebook as a "disconnected journey." To date, they are disappointed with consultation and feel the draft Guidebook last fall was presented as information rather than as open to real consultation. The FCC will be posting their Guidebook feedback on their website calgarycommunities.com in the coming days.

The updated version of the Guidebook will be live this week at calgary.ca/guidebook.

Official meeting adjourned at 7:05 p.m. where Councillor Farkas left meeting to start Town Hall. Meeting continued among some Community Association representatives who stayed in the room.

Life Cycle

Engineering Consulting Program (ECP)

The City of Calgary has a program to assist CA's with support major projects called "Engineering Consulting Program" (ECP).

Jenna Findlater communicated that Kingsland is a successful candidate for the Engineering Consulting program. She will file an application on behalf of Kingsland to be submitted to the city. Once KCA received more information, it will be communicated to the board.

KCA's Life Cycle Capital Projects

Capital project updates will be provided once the Engineering Consulting assessment is conducted.

The engineering assessment is required to move forward with our next application for a CCG grant.

Hockey Rinks Flooding and Maintenance

Brian is working well with Dick's mentorship and training to conduct the rinks maintenance.

KCA water hoses are old and are in need of repair (some have been patched several times). Dick communicated that it turns out there are more holes in the old hoses than he thought. We've had a string of hoses leaking, bursting, etc. creating icy patches around the rink, parking lot, etc.

Dick has recommended purchasing new hose or hoses (50 ft. and/or 100 ft.) for which he has received quotes. Dick will evaluate at the end of the season whether one or several hoses will need to be purchased (if the current hoses survive the season). The purchase budget is the absolute maximum money that would be required if we replaced two hoses with assemblies.

Motion: I, Tina Cohoon, make a motion to purchase a hose or several hoses for a budget of \$1800.00 for Kingsland hall for ice flooding. Second motion: <u>Kathy Mitchell</u>. All in Favour.

Action Item: Follow-up with Dick to purchase water hoses.

Action Item: Dick has not provided the instructions for operating the water system and automatic lights.

Rink Maintenance Issue

Dick discovered a little problem with the pin that locks one of the double gates (north one) in place. We (Dick and Brian) opened the gate and the weld attaching the pin bracket to the south gate was detached (low penetration weld failure). He had concerns is that it might be unsafe should someone slam into the gate, and it is meant to be pinned in place.

Dick contacted Nick Etchells the provider of the rink Global Sport Resources. He responded; I will send someone to weld it properly in the New Year. It is safe to use as the slide bars are more than enough. The cane bolts are more for an aesthetic aligning.

Action Item: Follow-up with Dick whether Nick had welded the pin bracket?

Hall Maintenance

Cris is coordinating with Dick monitoring required for hall maintenance.

Hockey Rink Replacement

Cris submitted the final reimbursement for CCG grant December 3, 2019 - \$ 6,871.19.

Jenna communicated that the grant folks were questioning firstly, the expenses that were submitted for the slats. Originally the slats were not considered for the grant – as they were deemed esthetics. The slats were installed to assist from snow blowing in the direction of the condos; without the slats the spring run-off was flooding in the condo garage. Jenna will submit a dispute for this item.

Secondly, the costs for the basketball poles extra, the city wanted more information. I forwarded to Jenna the Global quote to show items that were covered in the installation of the rink.

Action Item: Update board once the two items above are resolved.

<u>Social Director – Report</u>

Kingsland Helps Day will also feature - The *City of Calgar*y will have a table set up for an open discussion with regards to their project called the *Neighbourhood Streets program*, which is based around a new policy called the Neighbourhood Streets policy. When this policy is achieved, neighbourhoods are more resilient, and residents have the opportunities that come with access to safe travel choices and feeling connected. They are looking to get feedback and input from our community.
