Cris did not attend the President's meeting with Jeromy Farkas, Thursday, March 15, 2018 which was held at the Parkhill Stanley Park Community Hall due to weather conditions.

Next president meeting April 19, 2018

Clarke Court

Follow-up Item January 2018 meeting - Jeromy had asked KCA to give him 60 days to follow-up on the vacant building. Cris wrote an email to Jeromy Farkas March 16, 2018 - regarding the vacant status of Clarke Court.

The latest information received from City of Calgary; Affordable Housing as of March 21, 2018 - "We want to emphasize that the health and safety of tenants is paramount to The City and Calgary Housing Company. The City's top priority is ensuring the safety of the residents and buildings prior to moving tenants into all buildings. As deficiencies were addressed in Building 1 first (this is the westerly building), units are already occupied (3 families live there as of March 20, 2018) and additional tenants will move into more units of Building 1 by the end of March. Building 2 has approximately 5-7 weeks of additional construction work to be completed prior to begin being occupied."

Cris met with Luanne Whitmarsh and the Manager of Kerby Centre. They want to move from the downtown location, they are trying to get occupancy of the Old "Y" on Heritage, they will be going to City Council meeting in the near future to get confirmation whether they can occupy the building.

They wanted to meet to have a presence in the neighborhood. They will keep us posted on the progress as they get more information.

Tina communicated that in Vancouver back lane suites were not allowed if the back lane width did not meet the minimum width requirements; if an older area had narrow back lanes then suites would not be approved. Kingsland being an older area does have narrow back lanes. Chris, took the feedback to

forward to Jeromy. Cris also communicated that a resident did complain a few years back that cars were parked in the back alley which is narrow; the resident was challenged trying to get out of the garage.

Dear Constituents:

While in the midst of the Spring Legislative session, I am delighted to share the progress of our government provincially.

Economic growth exceeds expectations; deficit drops! While protecting public services for all Albertans.

Alberta's economy is leading the country with growth in nearly all sectors. In the third-quarter fiscal update, GDP growth is revised up to 4.5 per cent and the deficit dropped by \$1.4 billion. The lower forecast is a result of this government's continued efforts to constrain costs and improve revenue sources, such as higher non-renewable resource revenue, increased investment income and an improved balancing pool forecast.

Significant work has also been done to carefully find savings while continuing to support and protect the public services that all Albertans rely on. Whether it means negotiating practical agreements with public sector unions such as the Alberta Teacher's Association and the United Nurses of Alberta or extending the salary freeze in the public sector along with a hiring restraint across the public service. In addition, government corporate services have been consolidated and public agencies, boards and commissions have been reviewed resulting in cuts in salary and doing away with perks offered in the past. A high priority has been placed on restraining discretionary spending such as travel, all across government.

Community engagement on the South West Calgary Ring Road through several community meetings and presentations, continues and residents have provided valuable feedback. Alberta Transport together with multiple stakeholders have been able to provide ongoing information regarding plans, traffic changes and environmental considerations. To replace with touchless flush valves \$866.07 and to replace both \$1522.14; labour saving, if both done at the same time and hire Boyd's Plumbing to do the work at a cost of \$1522.14 GST included.
